from the supervisor's desk



Missing carts are the financial responsibility of the homeowner and may not be replaced without a police report. If damaged, only brown Stevens' carts will be replaced. Additional Stevens' carts may be rented annually through Stevens Disposal 1-800-779-0344. No more than three (3) brown carts will be emptied per household beginning January 1st, 2025.

Recycling: The Frenchtown Recycling center in the Mall of Monroe parking lot on the Phoenix Theaters side is operational every **Wednesday** from **7:00 AM - 3:00 PM** and a Frenchtown employee will be on site to ensure proper recycling procedures are being followed. Please remember that materials should be sorted and then separated into one of three differently (labeled) bins. There is a bin for cardboard and the other two bins are for plastic, paper, and tin. For additional information about recycling, a detailed image of acceptable material can be found on the Frenchtown Charter Township website under the Recycling tab.

Elections: Your Clerk's office along with its support from the entire election inspector team, has successfully administered the **2024 General Election**. We are extremely appreciative to the dozens of dedicated, election inspectors, for working all of the incredibly long hours required to help ensure the integrity and security of elections within our Township. The Township Board has been very productive over the past four years and together, as a team, we have accomplished many incredible tasks. That said I wanted to take this opportunity to thank **Christiaan Carlton** and **Matt Rimel** for all of your effort and support. It's been a privilege working side by side and learning from both of you while serving on the Frenchtown Township Board. I am proud of everything we were able to get accomplished together and even more proud to call you both friends. Serving on the Township Board has been the greatest privilege of my life. I consider myself blessed to be able to serve an incredible community with such a rich history and an even brighter future ahead.

 ${\sf S}$ ummer is over and life has returned to a more scheduled pace. Hopefully, it was enjoyable! School buses are now back on our roads, so drive carefully, as always, observing the speed limit to keep our children safe.

Summer was a busy time for the RDA and the remainder of the roads that were not previously overband crack sealed in 2023 was completed in August. This process extends the life of the roads by creating a tight seal over the crack and also protects the cracked edges along the surface from breaking up as traffic and snow plows pass over them. The tight seal also reduces the water that penetrates the asphalt, which freezes during winter causing greater asphalt breaking due to the expansion and contraction with temperature.

The RDA took advantage of a DTE Incentive Program for making energy-efficient equipment upgrades. The older street lights in the district have all been updated to the more energy efficient LED lights. The district received a bonus rebate, which will reduce the installation costs and will start capturing the estimated \$23,321.45 annual savings on electricity costs. In addition to the reduced electricity consumption, LED light fixtures have a much longer functioning expectancy thereby reducing maintenance costs.

We are continuing to progress in the Stoney Point Peninsula seawall project (Zone 2B/2C) and the project was submitted to the regulatory agencies for their review. However, EGLE has since changed the submission requirements and further delaying the overall review process. Fortunately, the Lake Erie water level continues its retreat towards the long term average away from the 100 year record high levels in 2019-2020.

Did you know the Monroe County Library System celebrated **go years** of library services in September of this year? As such, since its beginning in 1934, there have been many changes throughout the library system but the one thing that remains the same is our continuing endeavor for library excellence. The MCLS mission statement specifies that: *The Monroe County Library System enriches the quality of life for all residents of the county by providing free access to informational, educational, and recreational resources.*

There are a total of 16 branches in Monroe County, a Senior Outreach Vehicle, and a Bookmobile for children's services including 3 of the 16 branches being located right here in Frenchtown Township. The Frenchtown Library locations are as follows: Frenchtown-Dixie Branch at 2881 Nadeau Rd, the R.A. Vivian Branch at 2664 Vivian Rd, and the Blue Bush Branch at 2210 Blue Bush Road.

FYI, having a library card gives you access to MelCat, which is the statewide union catalog and resource sharing service pertaining to materials of all types amongst each of the libraries throughout Michigan. For example, if there is an item that the Monroe County Library System does not have in their collection, you can check to see if it is available to borrow elsewhere through MelCat. frenchtown fire department

t has been an exciting year for the Frenchtown Fire Department as we continue celebrating our Diamond Anniversary with **75 years** of serving our remarkable Township. We recently commemorated this historical anniversary during our Annual Open House, on October 5th, at Fire Station 3, located on Blue Bush Road.

Our origins began shortly after a tragic, fatal fire occurring on May 3rd 1948, in what was then known as Steiner Village, a small farming village located in what would later become Frenchtown Charter Township. Sadly, the fire claimed the lives of an elderly, bed-ridden woman, Mrs. Margaret Gibson, age 70 along with Magdalene Moyer, age 5 who was visiting at the time. It appears that there was a significant delay in the arrival of firefighters to perform the rescue of these precious women, as the closest fire department was located five miles south, in the City of Monroe. The delay along with raising concern among area residents led to the formation of the Frenchtown Township Volunteer Fire Department, established in 1949 to provide the residents of the then rural community with adequate fire protection. The firefighters were initially all volunteers who lived locally and the Department covered, roughly 43 square miles of territory. The first

Fire Chief, Henry Rambow was hired in 1950 and lived in a two-bedroom home adjacent to the main fire station with his wife and son.

Originally, the fire station had a direct emergency phone number and whenever the stations phone rang it also rang in both the Fire Chief's home and the Sheriff's Department. The Fire Chief's wife, who was also a dispatcher,









answered the phones and recorded the times. Firefighters were alerted both by the sound of a siren, and some by radios and pagers kept in their homes. Most of the volunteers were farmers so when they heard the siren, they would call the station to find out what the emergency was along with the location.

The Frenchtown Township Fire Department's Ladies Auxiliary was created by the mothers, wives and daughters of the firemen and routinely held bake sales, garage sales, and raffles to raise money and provide support for victims of fires.

Many changes have taken place during the past 75 years. The volunteer firefighters became paid-on-call firefighters, and in 1988 the Township residents approved a millage to add 12 full-time firefighters from among the paid-on-call ranks. Additionally, the original 1949 Ward-Lafrance fire engine has since grown into four fire engines, a platform tower truck, two brush trucks plus a fire pump mounted to a side by side and the single fire station has risen to four buildings in total. The Ladies Auxiliary became the Frenchtown Firefighters Association and in 1995, the original 12 full-time firefighters were increased to 18 full-time firefighters which remains our current full-time staffing level.

We have grown, changed, and evolved but our mission remains the same: The Frenchtown Fire Department's mission statement is the culmination of what was begun in 1949, "Committed to providing the highest quality all hazards service to the citizens and visitors of Frenchtown Charter Township through progressive training, prevention, and public education."

remember to take the time to protect all of you water lines and faucets from freezing. Taking just a little time now can save a really big headache later.

We are continuing to move forward with our **Residential Cross Connection** requirements from **EGLE**. If you have a lawn sprinkler, you can expect a letter from the Water

Winter tax bills will reach your mailbox by December 1st, 2024. Your bill is payable at the Treasurer's office or online until February 14th, 2025 without penalty and interest. Payments made after this date will incur a 3% interest charge and 1% penalty fee.

Winter tax payments will be accepted in the Treasurer's office until the end of business on February 28th, 2025. Real property taxes not paid by this date will be sent delinquent to the Monroe County Treasurer.


